ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
KNOTHE CORPORATION

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopts the following Articles of Amendment.

ARTICLE I

The name of the corporation is Knothe Corporation.

ARTICLE II

The following amendment was adopted in the manner provided for by the Alabama Business Corporation Act:

"The name of the corporation is hereby changed to: **Knothe Apparel Group, Inc.**"

ARTICLE III

The amendment was adopted by the shareholders in the manner prescribed by law on September 18, 2001.

ARTICLE IV

The number of shares outstanding at the time of the adoption was 450,004; the number of shares entitled to vote thereon was 450,004.

ARTICLE V

The number of shares voted for the amendment was 450,004 and the number of shares voted against such amendment was -0-.
