## CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, ASSIGNOR had adopted and used and was, to the best of its knowledge and belief, the owner of the trademarks listed in Schedule A, attached hereto and incorporated herein by this reference, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, causes of action, and the right to recover for past infringement (hereinafter collectively referred to as the "Trademarks");

WHEREAS ASSIGNEE and ASSIGNOR were and are both wholly-owned by Globe International Limited (the "Parent Corporation");

WHEREAS, ASSIGNOR had acquired goodwill associated with and symbolized by said Trademarks and had not abandoned the same;

WHEREAS, ASSIGNOR was prior to June 30, 2004, the owner of the federal trademark registrations relating to the Trademarks listed in Schedule B, attached hereto and incorporated herein by reference (hereinafter collectively referred to as the "Registrations");

WHEREAS, ASSIGNEE was desirous of acquiring all rights, title, and interest in and to the Trademarks and the Registrations; and

WHEREAS, ASSIGNOR was willing to assign to ASSIGNEE all rights, title, and interest as ASSIGNOR possessed in and to the Trademarks and the Registrations;

WHEREAS, ASSIGNOR did assign to ASSIGNEE, as of the effective date of this Assignment, all rights, title, and interest as ASSIGNOR did possess in and to the Trademarks and Registrations worldwide, together with the goodwill and business associated therewith, and certain tangible assets as indicia of said goodwill;

WHEREAS, ASSIGNOR confirms its assignment to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the Trademarks and Registrations worldwide and any other registered or unregistered trademark owned or used by ASSIGNOR worldwide;

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which hereby acknowledged, ASSIGNOR hereby confirms its assignment and sale to ASSIGNEE all rights, title and interest as ASSIGNOR may possess in and to the following.

- (1) The Trademarks set forth in Schedule A;
- (2) The Registrations set forth in Schedule B; and
- (3) Any other registered or unregistered trademarks owned or used anywhere in the world by ASSIGNOR;

together with the goodwill symbolized by said Trademarks, Registrations, and other registered or unregistered trademarks owned or used anywhere in the world by ASSIGNOR, concurrent with the transfer of certain tangible assets as indicia of said goodwill.
