ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks ("Assignment") is made as of April 14, 2004 by Orion Corporation, a company organized under the laws of Finland and having its registered office at Orionintie 1, (P.O. Box 65), 02200 Espoo, Finland ("Assignor"), to Abbott Laboratories, a corporation organized and existing under the laws of the State of Illinois and having a principal place of business at 100 Abbott Park Road, Illinois 60064-3537, USA ("Assignee").

PRELIMINARY STATEMENT

A. As of April 14, 2004, Assignee and Assignor entered into a License and Supply Agreement (the "Agreement") pursuant to which Assignor has agreed to sell to Assignee and Assignee has agreed to buy from Assignor the Acquired Assets (as defined in the Agreement), including the Trademarks. Pursuant to the Agreement, Assignor has agreed to execute such instruments of assignment as Assignee may reasonably request.

B. Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under Assignor's name, the trademarks, trade names, service marks, trade dress, logos, brandmarks, brand names, slogans and internet domain names, together with all translations, adaptations, derivations, and combinations thereof, and all applications, registrations and renewals for the foregoing set forth in Schedule A attached hereto, together with all common law rights associated with such registrations and applications and the goodwill associated therewith (the "Trademarks").

AGREEMENT

Assignor, for and in acknowledgement of receipt of the consideration set forth in the Agreement, hereby transfers and assigns to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under the Trademarks, and all causes of action, rights of recovery and claims for damages and other relief referring or pertaining to the Trademarks, including claims for past and future infringement, that may hereafter be secured under the laws now or hereafter in effect in countries in which such Trademarks are registered, the same to be held and enjoyed by Assignee, its successors and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

Except to the extent that federal law preempts state law with respect to the matters covered by this Assignment, it will be governed by and construed under the laws of Illinois without regard to conflicts of laws principles that would require the application of any other law.


