



CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, Elan Pharmaceuticals, Inc., a Delaware corporation with a place of business at 800 Gateway Boulevard South, San Francisco, CA 94080 ("Assignor"), pursuant to a merger with Carnick Laboratories, Inc. as of December 30, 1999, acquired all right, title and interest in and to the mark MIDRIN and United States Registration No.1,255,777, dated November 1, 1983, for "pharmaceutical preparation for treatment of vascular and tension headaches", together with all of the goodwill of the business represented and symbolized thereby;

This assignment shall be effective *nunc pro tunc* as of June 30, 2001.

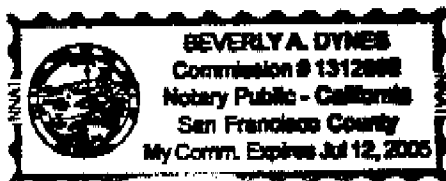
