RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated July 26, 2004 by Harris Trust and Savings Bank as hereinafter described;

WITNESSETH:

WHEREAS, the Assignor has requested that the Assignee release its security interests in the Trademarks and reassign the same to the Assignor;


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

- (i) Each Trademark, Trademark Registration and each Trademark Application listed on Schedule B attached hereto and made a part hereof, including without limitation all renewals thereof, all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements thereof, and all rights corresponding thereto throughout the world;
- (ii) The goodwill of the business to which each of the Trademarks relates.
