RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated July 26, 2004 by Harris Trust and Savings Bank as hereinafter described;

WITNESSETH:

WHEREAS, Harris Trust and Savings Bank, an Illinois banking corporation with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, as Agent (the "Assignee"), and HK Systems, Inc. (f/k/a Harnischfeger Engineers, Inc.), a Wisconsin corporation with its mailing address at 2855 South James Drive, New Berlin, Wisconsin 53151, (the "Assignor") are parties to the following certain Trademark Collateral Agreements:

- Trademark Collateral Agreement dated November 15, 1996 which was recorded in the United States Patent and Trademark Office on January 9, 1997 at Reel 1571, Frame 0196;
- Trademark Collateral Agreement dated October 9, 1998 which was recorded in the United States Patent and Trademark Office on October 19, 1998 at Reel 1815, Frame 0901; and
- Trademark Collateral Agreement dated February 13, 1995 which was recorded in the United States Patent and Trademark Office on February 27, 1995 at Reel 1297, Frame 0221

pursuant to which the Assignor granted security interests in and collateral assignments of certain trademarks listed on Schedule B attached hereto and certain other property (collectively the "Trademarks"); and

WHEREAS, the Assignor has requested that the Assignee release its security interests in the Trademarks and reassign the same to the Assignor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:



(i) Each Trademark, Trademark Registration and each Trademark Application listed on Schedule B attached hereto and made a part hereof, including without limitation all renewals thereof, all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements thereof, and all rights corresponding thereto throughout the world;

(ii) The goodwill of the business to which each of the Trademarks relates.
