Section 1060; and


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of

past, present, and future infringement, misappropriation, or dilution of the rights assigned to the  
Assignee hereunder, and all other rights corresponding thereto throughout the world.

The Assignor shall undertake, at the request of the Assignee, to sign all documentation,  
including confirmatory trademark and domain name assignments, and generally use reasonable  
best efforts to aid the Assignee, its successors, assigns and nominees, to obtain from the Assignor  
and record title to the Trademarks and domain names transferred herein in each jurisdiction  
where Trademarks are registered and applications to register Trademarks are pending.
