TRADEMARKS ASSIGNMENT

THIS TRADEMARKS ASSIGNMENT ("**Assignment**") is made effective as of June 27, 2004 by and among **CISCO-LINKSYS LLC**, a California limited liability company having its principal place of business located at 121 Theory Drive, Irvine, California 92612 ("**Linksys**"), and **CISCO TECHNOLOGY, INC.**, a California corporation, having its principal place of business located at 170 West Tasman Drive, San Jose, California 95134-1706 ("**CTI**").

"**Linksys Marks**" means all of Linksys' trademarks, service marks, trade names, trade dress, logos, designs and slogans, in word mark, stylized and/or design formats, including without limitation Linksys' trademark registrations and applications (except for Linksys' Intent-to-Use U.S. applications for which Amendments to Allege Use or Statements of Use have not yet been filed with the U.S. Patent and Trademark Office) and any and all of Linksys' common law rights in the aforementioned items, together with all good will associated with and symbolized by the aforementioned items, including without limitation the marks identified in Schedule 1 attached hereto and all of the good will associated with and symbolized by such marks;

Linksys has assigned and transferred, and CTI has received and accepted all of Linksys' rights, title and interest throughout the world in and to the Linksys Marks and all the rights, claims and privileges pertaining to the Linksys Marks, including without limitation: the registrations and applications pertaining thereto (except for Linksys' Intent-to-Use U.S. applications for which Amendments to Allege Use or Statements of Use have not yet been filed with the U.S. Patent and Trademark Office), together with all of the good will of the business associated with and symbolized by the Linksys Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Linksys in all matters related thereto.
