RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated July 31, 2004, is made by Harris Trust and Savings Bank, an Illinois banking corporation.

WITNESSETH:

WHEREAS, Harris Trust and Savings Bank, acting as administrative agent for itself and certain other lenders (hereinafter referred to as the "Secured Party"), and J.R. Wood, Inc., a California corporation (the "Debtor") are parties to a certain Trademark Security Agreement dated September 27, 2002, which was recorded in the United States Patent and Trademark Office on October 14, 2002, at Reel 002662, Frame 0511 (the "Assignment"), pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, registered trademarks, trademark applications, service marks, registered service marks and service mark applications listed on Schedule A attached hereto and certain other property (collectively, the "Trademarks"); and

WHEREAS, the Debtor has requested that the Secured Party release its security interests in the Assignment and the Trademarks and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Secured Party hereby releases and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Secured Party, all of its right, title and interest, if any, in and to all security interests and collateral assignments granted pursuant to the Assignment, including, but not limited to, all security interests in and collateral assignments of, all of the following:


(i) Each trademark, trademark registration and trademark application listed on Schedule A-1 hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) Each trademark license listed on Schedule A-2 hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and

(iii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages.
