**ASSIGNMENT OF SECURITY INTERESTS**  
**NUNC PRO TUNC**

This Assignment of Security Interests is effective as of August 29, 2003 (“Effective Date”) by and between BANK OF AMERICA, N.A. (“Prior Agent”) and SUNTRUST BANK (“Successor Agent”).

WHEREAS, Prior Agent and Successor Agent are parties to that certain Fourth Amendment to Credit Agreement dated as of August 29, 2003 (the “Amendment”), pursuant to which Successor Agent was appointed Agent, Issuing Lender and Swingline Lender in place of Prior Agent under a certain Credit Agreement dated as of December 11, 2001, as amended by that certain First Amendment and Assignment Agreement dated as of December 31, 2001, as amended by that certain Second Amendment to Credit Agreement and Waiver, dated as of July 15, 2002, as amended by that certain Third Amendment to Credit Agreement and Waiver, dated as of April 9, 2003, by and between Prior Agent, the Lenders and Borrowers (together with any other amendments, replacements, restatements or other modifications, the “Existing Credit Agreement” with all preceding capitalized terms not otherwise defined herein having the meanings given them in the Existing Credit Agreement);

WHEREAS, pursuant to security agreements contemplated by the Existing Credit Agreement, Borrowers granted to Prior Agent, as agent for the Lenders, a continuing security interest in and continuing lien upon, the patents, patent applications, trademarks and trademark applications attached hereto as Exhibit A and Exhibit B (collectively, the “Security Interests”);

WHEREAS, pursuant to Subpart 4.3 of the Amendment, Prior Agent has agreed to execute and deliver to Successor Agent this Assignment of Security Interests for recordation with the United States Patent and Trademark Office to evidence Successor Agent as the holder of the Security Interests as agent for the Lenders.

NOW, THEREFORE, be it known that for good and valuable consideration, receipt of which is hereby acknowledged, said ASSIGNOR did assign and transfer unto ASSIGNEE, its successors, assigns, and legal representatives, all right, title and interest

in and to the Security Interests as of the Effective Date. ASSIGNOR further agrees to execute all documents necessary to perfect such right, title, and interest in ASSIGNEE, its successors, assigns, and legal representatives.

If any term, provision or part of this agreement is to any extent held void, unenforceable or invalid by a court of competent jurisdiction, the remainder of this agreement shall not be impaired or affected thereby, and each term, provision and part shall continue in full force and effect, and shall be valid and enforceable to the fullest extent permitted by law.

This agreement may be executed in any number of counterparts, each of which shall constitute an original, but all of which together shall constitute one instrument notwithstanding that all parties are not signatories to the same counterparts.




