**HOLMES PRODUCTS CORP.**

**TERMINATION AND RELEASE OF TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT**, dated as of May 6, 2004, by **FLEET NATIONAL BANK**, a national banking association with its office at 100 Federal Street, Boston, Massachusetts 02110, as agent (hereinafter in such capacity, the "Agent"), in connection with the Revolving Credit Agreement, dated as of November 26, 1997 (as heretofore amended, and in effect, the "Credit Agreement"), by and among Holmes Products Corp. ("Holmes"), Holmes Products (Far East) Limited, Esteem Industries Limited, Raider Motor Corporation, the Agent and the lending institutions party thereto (the "Banks").

**WHEREAS**, in connection with the Credit Agreement, Holmes and the Agent entered into a Trademark Collateral Security and Pledge Agreement, dated as of November 26, 1997 (as supplemented by that certain First Supplemental Trademark Security and Pledge Agreement, dated as of February 5, 1999, the "Trademark Agreement"), which Trademark Agreement was recorded February 5, 1998 with the United States Patent and Trademark Office at Reel 1666, Frame 0821 for the purpose of securing payment and performance of the Obligations (as defined in the Credit Agreement);

**WHEREAS**, pursuant to the Trademark Agreement, Holmes granted to the Agent, for the benefit of the Agent and the Banks, a security interest in, and granted, assigned and conveyed to the Agent, for the benefit of the Agent and the Banks, by way of collateral security, Holmes' entire right, title and interest in and to, the Pledged Trademarks (as defined in the Trademark Agreement); and


**WHEREAS**, the Agent has agreed to terminate and release the Trademark Agreement and assign and transfer to Holmes its right, title and interest in the Pledged Trademarks as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates and releases the Trademark Agreement and assigns and transfers to Holmes, without representation, warranty or recourse, all of the Agent's right, title and interest in and to the Pledged Trademarks, including without limitation the trademarks listed on Exhibit A attached hereto, effective as of the date set forth above.
