In consideration of the Assignment recited herein, the parties hereby agree as follows:

1. Neither party will object to or prevent the use or registration by the other party, in any country of the world, of the formative *MAG* alone or the formative *MAG* with another word or symbol except as follows:

A. PORTER-CABLE CORPORATION will not use or register the formative *MAG* alone or the formative *MAG* with another word or symbol on bits including but not limited to DRILL BITS, AUGER BITS, FISH BITS, ACCESSORIES FOR BITS; HOLE SAWS and ACCESSORIES FOR HOLE SAWS, AND KITS MADE UP OF ANY OF THE FOREMENTIONED BITS, ACCESSORIES AND HOLE SAWS; HACK SAWS, RECIPROCATING SAW BLADES, JIG SAW BLADES AND HACK SAW BLADES; AND CUTTING FLUID.

B. MAGNUS INDUSTRIES, INC. will not use the formative *MAG* alone or the formative *MAG* with another word or symbol on POWER OPERATED SAWS, NAILERS, ROUTERS AND SANDERS.
