ARTICLES OF MERGER OR SHARE EXCHANGE

BUSINESS CORPORATION

Pursuant to §55-11-05 of the General Statutes of North Carolina, the undersigned corporation as the surviving corporation in a merger hereby submits the following Articles of Merger.

1. The name of the surviving corporation is Materials, Communication and Computers, Inc., a corporation organized under the laws of the State of North Carolina ("MATCOM"); the name of the merged corporation is MACA CORPORATION, a corporation organized under the laws of the State of Texas.
2. Attached hereto is a copy of the Agreement and Plan of Merger that was duly approved in the manner prescribed by law for each of the corporations participating in the merger.
3. Shareholder approval was not required for the merger on the part of MATCOM but said Agreement and Plan of Merger was approved by the Board of Directors of MATCOM as required by Chapter 55 of the North Carolina General Statutes.
4. Neither shareholder nor Board approval was required for the merger on the part of the corporation that will not survive the merger under the laws of the State of Texas, the State in which said corporation was incorporated, as it is a wholly-owned subsidiary of MATCOM.
5. These Articles of Merger shall be effective upon acceptance for filing by the Secretary of State of the State of North Carolina.
