**RELEASE OF TRADEMARK SECURITY AGREEMENT**

WHEREAS, Ducane Gas Grills, Inc. (f/k/a The Ducane Company, Inc.) a South Carolina corporation having a place of business at 800 Dutch Square Boulevard, Columbia, South Carolina 29210, (hereinafter referred to as "Ducane"), and Fleet Capital Corporation, a Rhode Island corporation having a place of business at 6100 Fairview Road, Charlotte, North Carolina 28210 (hereinafter referred to as "Fleet") entered into a certain Trademark Security Agreement dated January 17, 2003 (the "Security Agreement");
