RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is executed as of this 14th day of May, 2004, by NATIONAL CITY BANK, a national banking association in its capacity as agent (the "Agent") for itself and each financial institution from time to time party to the Credit Agreement (hereafter defined) (the "Banks").

WHEREAS, Rainbow Rentals, Inc., an Ohio corporation (the "Borrower"), the Agent, and the Banks entered into that certain Credit Agreement dated as of January 11, 2002 (as amended through the date hereof, the "Credit Agreement").

WHEREAS, in connection with the Credit Agreement, the Borrower and the Agent entered into that certain Patent, Trademark and Copyright Security Agreement, dated as of January 11, 2002 (the "Security Agreement").

WHEREAS, pursuant to the terms and conditions of the Security Agreement, Agent was granted a security interest in all of the Borrower's interest in the collateral more specifically described on Exhibit A attached hereto ("Collateral").

Such Security Agreement was filed with the United States Patent and Trademark Office on June 24, 2003, and recorded against the Collateral on Reel 002763/Frame 0930.

WHEREAS, the Agent has received consideration for a full and complete release of the security interest in and liens in the Collateral, and now wishes to release such security interest and liens in the Collateral.

NOW THEREFORE, Agent represents and agrees as follows:


1. Agent hereby releases, cancels and terminates all of its right, title and interest in and to the Collateral, including its security interest in and liens on the Collateral and all other rights with respect to the Collateral, and conveys and assigns any and all right, title and interest that it may have in and to the Collateral to Borrower.
2. Agent represents that it has not exercised any of the rights with respect to the Collateral available to it under the Security Agreement. Agent represents and warrants that it has not sold, licensed, conveyed or otherwise alienated any rights in and to the Collateral, and that it has not practiced or sublicensed any of the Collateral.
3. Without limiting the generality of the foregoing, this Release is intended to and shall forever terminate the irrevocable rights in the Collateral granted and conveyed to Agent under the Security Agreement and in any other Loan Document (as such term is defined in the Credit Agreement) and reconvey such rights to Borrower.

IN WITNESS WHEREOF, the Agent has caused this Release to be duly executed by its officer thereunto duly authorized as of the date hereof.


