

### AGREEMENT

THIS AGREEMENT ("Agreement") is entered into, as of the date of the later signature below (the "Effective Date"), between Cox Interactive Media, Inc., with an address at 530 Means Street, Atlanta, Georgia 30318 ("Assignor"), and Jon Rawl, with a mailing address at P.O. Box 1217, Oxford, Mississippi 38655 ("Assignee").

WHEREAS, Assignor has used and registered the service mark Y'ALL (the "Mark"), and has registered the Mark with the United States Patent and Trademark Office (Reg. No. 2,059,849) (the "Registration");

WHEREAS, Assignor has registered the Internet domain name yall.com (the "Domain Name"); and

WHEREAS, Assignee wishes to acquire the Mark and the Domain Name.

THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties, intending to be legally bound, agree as follows:

1. Provided that Assignee pays the amount due to Assignor in accordance with Section 2, Assignor assigns to Assignee all of Assignor's right, title and interest in the Mark, including the Registration and the goodwill of the business symbolized by the Mark. Assignor hereby agrees to transfer and assign the Domain Name to Assignee in accordance with the terms of this Agreement.

2. Within five (5) days after the Effective Date, Assignee will pay \$1,000.00 to Assignor. Within ten (10) days after the date that Assignor receives such payment from Assignee, Assignor will assign the Domain Name to Assignee.

3. The terms and conditions of this Agreement, with the exception of the existence of this Agreement, will be kept confidential by the parties and will not be disclosed to any third party except as may be required by any court or governmental agency, and except to a party's accountants, auditors, agents, legal counsel and parent companies.

4. This Agreement will be governed by the laws of the State of Georgia, without regard to Georgia's choice of law provisions. This Agreement constitutes the entire agreement and understanding between the parties hereto with respect to the subject matter hereof, and this Agreement supersedes all prior and contemporaneous agreements, understandings, and discussions between the parties, whether written or oral, with respect to such subject matter. Any amendment or modification to this Agreement must be in writing and signed by both
