



**SUPPLEMENTARY DEED OF A PLEDGE DEED FOR THE  
LICENSING OF TRADEMARKS**

With the present private deed between:

ATALA S.p.A., company constituted under Italian law, with Head Office in Padova, Via Lussemburgo 31/33, registered at the Padova Company Register, tax code and registration number: 02651030278, represented by the Managing Director PERONI CARLO FRANCESCO, born in La Spezia on 3 August 1937, resident in Ivrea, Strada Vicinale S. (hereafter the Licensor)

on one side

and

BANCA ANTONIANA POPOLARE VENETA S.p.A., company constituted under Italian law (Bank registered with no. 5310 of the Association of Banks and with no. 5040.1 of the Association of Bank Groups), with Head Office in Padova, Piazzetta Turati no. 2, registered at the Padova Company Register, registration number, tax code and VAT number 02691680280, acting as pledging creditor, in the person of Dr. Cosimo Lombardi, born in Taranto, 15 March 1965 and Dr. Alberto Bertossi, born in Busto Arsizio (VA), 1 February 1967 domiciled for the position at the Head Office;

on the other side

**CONSIDERING**

- that on 27 June 2002 with deed in index no. 8283 of Attorney Alberto Benazzato, Notary in Padova, registered at the

Registry Office of Padova on 9 July 2002 with no. 3736, ATALA S.p.A. irrevocably licensed a pledge in the first degree in favour of BANCA ANTONIANA POPOLARE VENETA S.p.A. on the trademarks owned by ATALA S.p.A. according to attachment "A" to the present deed, as well as all of the other rights relative to them like, for example, any possible renewal of the licensing and/or registration of the trademarks pursuant to article 3 of Trademark law, required by whoever;

- that the pledge established pursuant to the present deed shall extend to every trademark, different to the trademarks, of which ATALA S.p.A. shall become the proprietor or in any case owner or which needs to be registered after the date of the present deed (additional trademarks);
- that the list of registrations and/or applications for registration of the trademark is not sufficiently precise and complete;
- and that the parties now intend to add the missing data;

#### **CONSIDERING THE ABOVE**

- 1) ATALA S.p.A. and BANCA ANTONIANA POPOLARE VENETA S.p.A. mutually declare that in virtue of the pledge quoted in the preamble, pledges on the registrations and/or applications for registration of trademarks shown in attachment "A" of the present supplementary pledge deed were respectively licensed.
- 2) The parties henceforth undertake to sign any further document that may become necessary or even simply suitable for the

purpose of obtaining the registration of the pledge licensing deed on the registrations and/or applications for registration of trademarks owned by ATALA S.p.A.

- 3) The undersigned parties ask that the transcription of the present deed at the Italian Patent and Trademark Office of Rome and all of the costs inherent to such an operation are the responsibility of ATALA S.p.A.
