REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of March 15, 2004 by AGILITY CAPITAL, LLC ("LENDER") to RAYCOM TECHNOLOGIES, INC., a California corporation formerly known as Precis Design Corporation, with its principal place of business at 871 Fox Lane, San Jose, CA 95131 ("COMPANY").

Recital
