Declarant, Ed Boyce, under oath, states the following:

1. He is President of Electro-Magic Equipment, Inc., which is incorporated under the laws of the State of Nevada, currently located at 1105 Poinsetta Street, Santa Ana, CA 92701.
2. As an officer of Electro-Magic Equipment, Inc., he is duly authorized to sign this Declaration on behalf Electro-Magic Equipment, Inc.
3. Assets of Electro-Magic, Inc. were sold to Electro-Magic Equipment, Inc. in approximately 1986.
4. United States trademark Registration Nos. 700,525 and 816,992 (both for the mark ELECTRO-MAGIC), along with the goodwill associated with the trademarks, were a part of the aforementioned purchase of Electro-Magic, Inc. assets by Electro-Magic Equipment, Inc.

5. The documents evidencing the sale of Electro-Magic, Inc. assets to Electro-Magic Equipment, Inc. are no longer available.

6. Certain assets of Electro-Magic Equipment, Inc., including the above-noted trademark registrations and the goodwill associated with the trademarks, were subsequently sold to Alkota Cleaning Systems, Inc., the current owner of the registrations, by an Asset Purchase Agreement effective May 31, 2000.

7. The current owner of the registration, Alkota Cleaning Systems, Inc., is now and/or will be seeking to renew these registrations.

8. The purpose of this Declaration is to attest to the sale of assets of Electro-Magic, Inc. to Electro-Magic Equipment, Inc. in light of the unavailability of the documents evidencing the sale in order to perfect the chain of title to these registrations and to facilitate the renewal of the above registrations in the U.S. Patent and Trademark Office by current owner, Alkota Cleaning Systems, Inc.

The undersigned being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1004, and that such willful false statements and the like may jeopardize the validity of the registrations referenced herein, declares that all statements made of his own knowledge are true, and all statements made on information and belief are believed to be true.
