Assignor hereby irrevocably appoints Assignee as Assignor's attorney-in-fact for the purpose of executing all such documents as may be necessary for securing, recording or otherwise effectuating this Assignment in Assignor's name, and Assignor shall cooperate with Assignee in Assignor's efforts to perfect its title to the Marks.

This Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts shall together constitute one and the same instrument.
