**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

WHEREAS, CREATIVE PACKAGING CORP. 
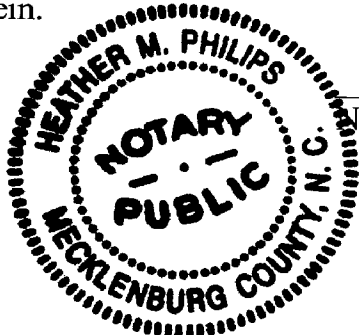
