Release And Reassignment

THIS RELEASE AND REASSIGNMENT is made this 31st day of August, 2004 by Bank of America, N.A., successor to Nationsbank of Tennessee, N.A. ("Bank of America").

WITNESSETH:

WHEREAS, Bank of America and Nashville Hockey Club Limited Partnership, a Wisconsin limited ("Borrower") are parties to a certain Amended and Restated Credit Agreement dated as of January 29, 2001, as it may be amended from time to time (the "Credit Agreement") pursuant to which the Lenders party thereto made certain loans and other financial accommodations (the "Loans") to Borrower. As partial security for Borrower's liabilities, under the Credit Agreement, Borrower has executed a certain Security Agreement (as amended, the "Security Agreement") dated as of May 1, 1998, pursuant to which Borrower granted a security interest in and to the "Trademarks" as defined below; and

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on February 2, 2001 at Reel 002232, Frames 0655 - 0716; and

WHEREAS, the liabilities under the Credit Agreement have been fully satisfied and, therefore, Borrower has requested that Bank of America release its security interest in the Trademarks and reassign the same to Borrower.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Bank of America hereby releases its security interest in all of Borrower's right, title and interest in and to all of its now owned or existing and filed and hereafter acquired or arising and filed:

(a) trademarks, trademark registrations, tradenames and trademark applications, including, without limitation, the trademarks and applications listed on Schedule A, attached hereto and made a part hereof, and (a) renewals and extensions thereof, (b) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including without limitation, damages and payments for past or future infringements thereof, (c) the right to sue for past, present and future infringements thereof, and (d) all rights corresponding thereto throughout the world (all of the foregoing trademarks, trademark registrations, tradenames and applications, together with the items described in clauses (a)-(d) of this subparagraph, are hereinafter referred to as the "Trademarks"); and


(b) the goodwill of Borrower's business connected with and symbolized by the Trademarks.

2. Bank of America hereby reassigns, grants and conveys to Borrower, without any representation, recourse or undertaking by Bank of America, all of Bank of America's rights, title and interest, in and to the Trademarks.
