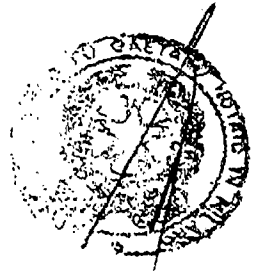

The Parties agree as follows:

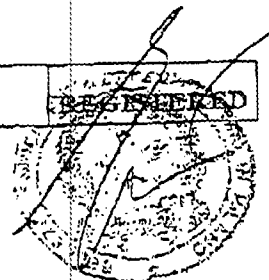
