WHEREAS, Purchaser is desirous of acquiring the Marks and the good will associated therewith; and



Upon the request of Purchaser any time after the Closing, Seller will forthwith execute and deliver such instruments of assignment, transfer and other documents as Purchaser or its counsel may request in order to perfect title to the Marks or otherwise to effectuate the purposes of this Assignment.


