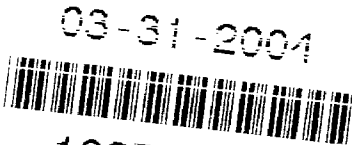



TRADEMARK ASSIGNMENT

WHEREAS, Cemprus LLC, a limited liability company organized and existing under the laws of the State of Delaware (hereinafter referred to as "Cemprus"), is the owner of the entire right, title and interest in and to the trademark identified on Schedule A attached hereto together with the goodwill related thereto (hereinafter referred to as the "Mark");

WHEREAS, Stratus Technologies Bermuda Ltd., a corporation organized and existing under the laws of Bermuda (hereinafter referred to as "Buyer"), is desirous of acquiring the entire right, title and interest in and to the Mark and the goodwill of the business in connection with which the aforesaid Mark has been used;

WHEREAS, pursuant to a certain series of transactions concerning Cemprus and Buyer, including the Agency, Assignment and Assumption Agreement, dated as of January 30, 2003 (the "Closing Date") and the Membership Interest Purchase Agreement dated as of February 11, 2003, the parties intended that the Mark be transferred to Buyer; and

WHEREAS, Cemprus and Buyer agree that this Agreement may be executed in two or more counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, Cemprus hereby assigns to Buyer, its successors, legal representatives and assigns, nunc pro tunc, effective as of the Closing Date (January 30, 2003), the entire right, title, and interest of Cemprus in and to the Mark, together with the goodwill of the business connected with the use of and symbolized by the Mark, and all claims, if any, which may have arisen thereunder prior to the date of this instrument.
