It is understood that the Trade-mark is assigned as per its current status, the Assignor not making any representation as to its value and validity, which is accepted by the Assignee.

Notwithstanding any other provisions of this Assignment of Trade-Mark to the contrary, nothing contained in this Assignment of Trade-Mark shall in any way supersede, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge or in any way affect the provisions, including warranties, covenants, agreements, conditions, representations or, in general any of the rights and remedies, and any of the obligations and indemnifications of Amcor or the Assignee set forth in the Purchase Agreement nor shall this Assignment of Trade-Mark expand or enlarge any remedies under the Purchase Agreement including without limitation any limits on indemnifications specified therein. This Assignment of Trade-Mark is intended only to effect the transfer of the Trade-Marks pursuant to the Purchase Agreement and shall be governed entirely in accordance with the terms and conditions of the Purchase Agreement.
