**TERMINATION OF SECURITY INTEREST  
(Trademarks)**

This **TERMINATION OF SECURITY INTEREST**, dated as of March 19, 2004, is made by Deutsche Bank Trust Company Americas (formerly named Bankers Trust Company), as Agent for the Lenders (the "Agent").
