RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of August 16, 2004 (this "Release") is made by Comerica Bank, as Agent ("Secured Party") under the Security Agreement dated as of September 16, 2002, and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 002590 Frame 0953, between BJK Holdings, Inc. 
