ASSIGNOR agrees that, upon request, it will sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining the Mark in all countries and for vesting title thereto in ASSIGNEE, its successors, assigns and legal representatives or nominees.

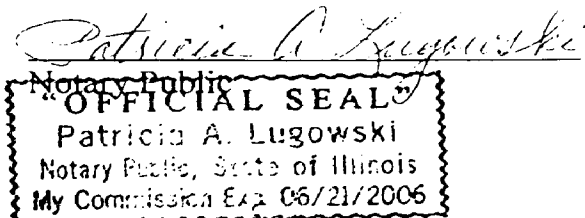
