CONFIRMATORY ASSIGNMENT

WHEREAS, Columbia Sportswear Company, an Oregon corporation ("CSC"), has adopted and used numerous trademarks which are the subject of U.S. trademark applications or registrations;

WHEREAS, CSC is in the business of manufacturing and selling certain goods itself, and is also in the business of licensing its trademarks to third parties with respect to other goods;

WHEREAS, some of CSC's marks relate to CSC's manufacturing business and some of CSC's marks relate to CSC's licensing business;

WHEREAS, CSC has formed a subsidiary company, Columbia Sportswear North America, Inc., an Oregon corporation ("CSNA"), and desires to transfer all of said marks to CSNA along with the goodwill associated with said marks. In addition, CSC is transferring to CSNA all of its licensing business. CSNA will grant a license back to CSC with respect to those marks which are used in CSC's business of manufacturing and selling goods and will operate the entire business of licensing marks to third parties itself; and

WHEREAS, all of the trademark registrations being assigned herein are listed in Appendix A and all of the trademark applications being assigned herewith are listed in Appendix B.

NOW, THEREFORE, for One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, CSC hereby sells, transfers, conveys and assigns unto CSNA its entire right, title and interest in and to all of the trademarks listed in Appendices A and B and the registrations and applications associated therewith together with the goodwill of the business in connection with which said marks are used, and the entire business of licensing certain of said marks. This Assignment is confirmatory of an earlier Assignment dated January 1, 2002 and is effective as of that date.

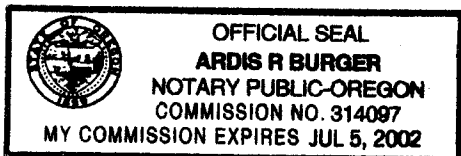
