**TRADEMARK ASSIGNMENT**

This Trademark Assignment ("Assignment") is made and effective as of July 13, 2004 ("Effective Date"), from WEF Basel AG in Liquidation (previously WEF Basel AG), a corporation organized under the laws of Switzerland, having seat at c/o Rebus Treuhand AG, Birsigstrasse 26, 4054 Basel, Switzerland, acting through its liquidator Mr. Jean-Daniel Simon, with the address Simon & Cie, 20 av. des Amazones, 1224 Chêne-Bougeries, Switzerland ("Assignor"), to Global Insight, Inc., a corporation organized under the laws of the state of Delaware and having a place of business at 1000 Winter Street Suite 4300, Waltham, Massachusetts 02451 ("Assignee").

**WHEREAS**, Assignor is the owner of the trademark AREMOS, including but not limited to the applications and registrations set forth on Schedule A hereto, and the goodwill associated therewith ("the Mark"); and


**WHEREAS**, Assignee desires to acquire ownership of the Mark, and Assignor desires to assign ownership of the Mark to Assignee;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, transfer, convey and assign to Assignee, and Assignee hereby accepts, (i) the entire right, title, and interest in the Mark (and any variations thereof) worldwide, (ii) goodwill of the business appurtenant thereto and which is symbolized thereby, (iii) the right to sue, counterclaim, and recover for past, present, or future infringement or other violation of the rights assigned Assignee hereunder, and (iv) every priority right that is or may be predicated upon or arise from said Mark, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors and assigns, to be used as fully and entirely as said rights would have been held and enjoyed by Assignor if this assignment had not been made.


Assignor hereby authorizes the U.S. Patent and Trademark Office to record the transfer of the Mark to Assignee as assignee of Assignor's entire right, title, and interest therein. Assignor shall, at the request of Assignee, execute and deliver further instruments of transfer and assignment and take such other action as Assignee may reasonably request to more effectively transfer and assign to, and vest in, Assignee all rights in the Mark.
