IN WITNESS WHEREOF, Ehlert has caused this Assignment of Trademarks to be executed by its duly authorized officer on the 30th day of August, 2004.

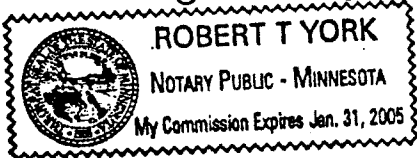
