b. agrees from time to time to execute and deliver all such other and further instruments and documents as may be necessary to transfer and convey the Intellectual Property to Assignee, its successors, assigns and legal representatives; and


c. agrees to furnish to Assignee upon its request and without further consideration all records in the possession of Assignor necessary to establish priority of invention in any interference or similar proceeding in connection with any of the Intellectual Property.

2. No representations and warranties, or indemnification agreements with respect to the Intellectual Property, are made in this Assignment but instead are expressly disclaimed, it being understood and agreed that all of the rights of Assignor and Assignee with respect to the Intellectual Property are governed by the Stock Purchase Agreement.


