ASSIGNMENT OF SECURITY INTEREST IN U.S. PATENTS AND TRADEMARKS

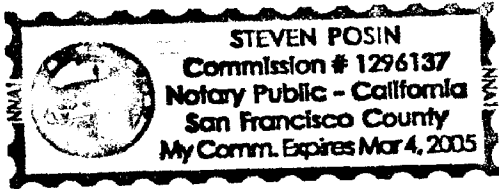
