ASSIGNMENT OF TRADEMARKS AND LICENSE BACK

WHEREAS, HEALTHCARE.COM CORPORATION, a corporation organized under the laws of the state of Georgia and a wholly owned subsidiary of QUOVADX, INC., desires to assign all trademark rights it possesses in and to the following mark registered with the United States Patent and Trademark Office (hereinafter the "Mark"):

WHEREAS, HAZEN ENTERPRISES, INC., a corporation organized under the laws of the state of Kansas, is desirous of acquiring all said trademark rights HEALTHCARE.COM CORPORATION possesses in and to the Mark and the registration therefore;

WHEREAS, Healthcare.COM CORPORATION is desirous of phasing out use of the Mark and HAZEN ENTERPRISES, INC., is willing to grant HEALTHCARE.COM CORPORATION a non-exclusive, non-assignable, worldwide, royalty-free license for the purpose of phasing out use of the Mark;

WHEREAS, the Parties have entered into a Domain Name Purchase Agreement of even date hereof, the terms and conditions are expressly incorporated herein and made a part hereof;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Parties agree as follows:

1. HEALTHCARE.COM CORPORATION hereby assigns to HAZEN ENTERPRISES, INC., effective the date hereof, all trademark rights it possesses in and to the Mark together with the goodwill of the business symbolized by the Mark and the identified registration thereof.
2. HAZEN ENTERPRISES, INC. hereby grants to HEALTHCARE.COM CORPORATION and its affiliate, QUOVADX, INC., and their affiliates, subsidiaries, parents, distributors and agents a non-exclusive, non-assignable, non-revocable worldwide, royalty-free license to use the Mark for a term of six months herefrom for the purpose of phasing out use of the Mark so long as HEALTHCARE.COM CORPORATION and/or QUOVADX, INC. use the Mark in substantially the same manner as their use prior to the date hereof (the "License Term").
3. HAZEN ENTERPRISES, INC. hereby consents in perpetuity to the continued royalty-free use of the Mark after expiration of License Term of any materials or products that HEALTHCARE.COM CORPORATION and/or QUOVADX, INC. and their affiliates, subsidiaries, parents, distributors or agents had previously distributed to third parties during the license period or prior to the date of this Agreement, including new copies of such products or materials which HEALTHCARE.COM CORPORATION and/or QUOVADX, INC. and their affiliates, subsidiaries, parents, distributors or

agents may cause to be distributed after the date of this Agreement under maintenance or support agreements in effect as of the date of this Agreement.

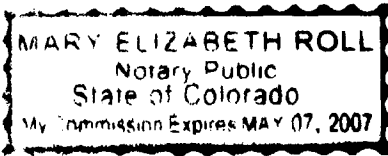

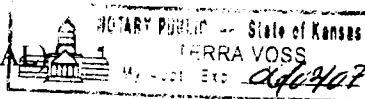
