## TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT, dated as of April 1, 2004 by HOLLAND AMERICAN WAFER COMPANY, a Michigan corporation ("Grantor"), OF 3300 Roger B. Chaffee Memorial Drive SE, Grand Rapids, Michigan 49548-2367, in favor of FIFTH THIRD BANK., a Michigan banking corporation ("Grantee"), of 111 Lyon Street NW, Grand Rapids, Michigan 49503.

### WITNESSETH:

WHEREAS, pursuant to that certain Restated Loan Agreement dated as of April 1, 2004 by and among Grantor and other parties, on the one hand, and the Grantee, on the other hand, (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Loan Agreement"), Grantee has agreed to extend credit for the benefit of Grantor and others; and

WHEREAS, pursuant to the Loan Agreement, Grantor is required to execute and deliver to Grantee this Trademark Security Agreement.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in Section 1 thereto to the Loan Agreement.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Grantor hereby grants to Grantee a continuing first priority security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

(a) all of its trademarks and trademark licenses to which it is a party including those referred to on Schedule I hereto;

(b) all reissues, continuations or extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each trademark and each trademark license; and

(d) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any trademark or trademark licensed under any trademark license or (ii) injury to the goodwill associated with any trademark or any trademark licensed under any trademark license.

3. LOAN AGREEMENT. The security interests granted pursuant to this Trademark Security Agreement are granted in conjunction with the security interests granted to Grantee pursuant to the Loan Agreement and prior documents. Grantor hereby acknowledges and affirms that the rights and remedies of Grantee with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Loan Agreement and the Security Agreement dated as of September 1, 2002 between Grantor and Grantee, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


