

WHEREAS, said Nestor Plasencia has, in accordance with the terms of the Agreement, designated ^{INVERSIÓN SA} MSLA SOCIEDAD ANONIMA, a company organized and existing under the laws of the Country of Honduras and having a principal place of business at CARRETERA DANLI, EL PARAISO, KILOMETRO 5, SAN MARCOS, DANLI, EL PARAISO HONDURAS ("Assignee") as the affiliate which will accept the assignment of the Trademarks and the goodwill associated therewith; and

WHEREAS, Assignee is desirous of acquiring the Trademarks, the goodwill associated therewith;

NOW, THEREFORE, effective on and as of May 10, 2002, for good and valuable consideration; the receipt and sufficiency of which is hereby acknowledged and to implement the transaction contemplated by the Agreement, Assignor, pursuant to, and subject to the terms of, the Agreement, hereby sells, assigns and transfers to Assignee, as successor-in-interest to the business of Assignor related thereto all right, title, and interest, free and clear of all liens and encumbrances, in and to all Trademarks, together with the goodwill relating thereto, all income, royalties, damages and payments now or hereafter due or payable in respect to the Trademarks, and all causes of action (either at law or in equity) and the right to sue, counterclaim and recover for past, present and future infringement of the Trademarks and the rights thereto.


