TRADEMARK AND DOMAIN NAME ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made this 15th day of September, 2004 by ASSA ABLOY Door Group, LLC, a Delaware limited liability company (the "Assignor") to Trussbilt, LLC., a Minnesota limited liability company (the "Assignee").

WHEREAS, Assignor and Assignee have entered into an Asset Purchase Agreement (the "Agreement"), dated the date hereof, pursuant to which Assignor has agreed to sell, transfer and assign to Assignee, and Assignee has agreed to acquire, substantially all of the assets of the Seller's business;

WHEREAS, included among the assets being acquired by Assignee pursuant to the Agreement are the trussbilt.com domain name ("Domain Name") in which Assignor is the beneficial owner and the trademarks identified on Exhibit A hereto (the "Trademarks"); and

WHEREAS, Assignor desires to assign, convey, and transfer all of its right, title, and interest in and to the Domain Name and Trademarks, together with the goodwill of the business connected therewith;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor hereby assigns to Assignee all rights, title, and interest and goodwill worldwide in and to the Domain Name and the Trademarks throughout the world, including without limitation all right, title, and interest in and to all common law rights and related goodwill in and to the Domain Name and Trademarks and any other registration or applications filed, together with the goodwill associated therewith; all rights of priority therein in any jurisdiction of the world as may now or hereafter be granted to it by law, treaty, or other International Convention; and all rights, interests, claims, and demands recoverable in law or in equity that it has or may have in profits and damages for past, present, and future infringements.
2. Assignor undertakes that upon the request of Assignee or its designees, it and/or its successor in business, will make all rightful oaths, testify on behalf of Assignee or its designees in matters involving the Trademarks and do all other lawful acts necessary to carry out the intent of this Assignment, as well as to provide such other material, information, and assistance to Assignee or its designees, as will be considered necessary in connection therewith.
3. Within fourteen (14) business days following execution of this Agreement, Assignor agrees to change the administrative, technical and billing contacts and the host server information listed in Network Solutions records to the contact and host server information provided in writing by Assignee. Assignor agrees to provide such other information and execute such other documents as may be necessary to accomplish the transfer of the Domain Name upon Assignee's reasonable request.
