SERVICE MARK ASSIGNMENT AGREEMENT

This SERVICE MARK ASSIGNMENT AGREEMENT ("Agreement") is made effective as of the 8 day of SEPTEMBER 2004 ("Effective Day"), by and between Birch Telecom, Inc. ("ASSIGNEE"), a Delaware corporation with a business address of 2020 Baltimore Ave., Kansas City, MO 64108, and SPRAWLNET.COM INC ("ASSIGNOR"), a Florida corporation with a business address of 1811 NE 146th Street, North Miami, FL 33181. ASSIGNOR AND ASSIGNEE are sometimes collectively referred to herein as the "Parties."

WHEREAS, ASSIGNOR has adopted, has used, and is using in its business, the SPRAWLNET service mark ("Mark"), as evidenced by the Amendment to Use filed in the United States Patent and Trademark Office ("USPTO") on March 29, 2000, and which pending application for registration is identified by Application Serial No. 75/697,175, and;

WHEREAS, ASSIGNEE desires to acquire the Mark, the registration thereof and application therefor, and all of the rights to and interests therein.

NOW, THEREFORE, TO ALL CONCERNED, be it known for and in consideration of the sum of Four Thousand Dollars (\$4,000.00) and other good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR hereby makes the transfer and assignment of all rights in the Mark as follows:

19. ASSIGNOR does sell, assign, and transfer all its right, title, and interest, anywhere in the world, in and to the Mark onto ASSIGNEE and the registration thereof and the application therefor, together with the goodwill of the business in connection with which said Mark is used and that part of the goodwill of the business connected with the use of and symbolized by said Mark.

20. ASSIGNOR further agrees to execute and deliver such other or further documents or instruments as may be necessary, in the judgment of ASSIGNEE's counsel, to perfect ASSIGNEE's rights in and to the Mark.

21. This Agreement provided hereby includes any and all rights, use for and recover all damages for infringement of the Mark, whether such infringement occurred in the past or occurs in the future, as fully as if ASSIGNOR had filed such action in its own name. Further, ASSIGNOR agrees to cooperate in any such actions the extent reasonably required by ASSIGNEE to enforce the rights transferred hereunder.
