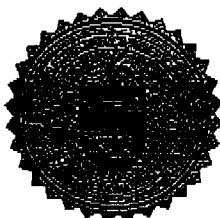

Pursuant to Section 252(c) of the General Corporation Law of the State of Delaware:

K. Hovnanian Forecast Acquisition, Inc., a California corporation, hereby certifies that:

1. The constituent corporations of the merger effected hereby (the "Merger") are K. Hovnanian Forecast Acquisition, Inc., a California corporation ("Forecast"), and K. Hov A, Inc., a Delaware corporation ("K. Hov A").
2. A Plan and Agreement of Merger (the "Agreement") has been approved, adopted, certified, executed and acknowledged by Forecast and by K. Hov A in accordance with the provisions of Section 252(c) of the General Corporation Law of the State of Delaware and Section 1108 of the General Corporation Law of the State of California.
3. Forecast shall be the surviving corporation of the Merger.
4. The Articles of Incorporation of Forecast shall be the Articles of Incorporation for the surviving corporation, except that Article 1 of the Articles of Incorporation of the surviving corporation shall be amended to state as follows: "The name of this corporation shall be K. HOV I P, INC. (hereinafter the "Corporation")."
5. The executed Agreement is on file at the office of Forecast, which is located at 2495 Campus Drive, Irvine CA 92612. A copy of the Agreement will be furnished by Forecast, on request and without cost, to any stockholder of any constituent corporation.
6. This Certificate of Merger shall be effective upon filing.

7. K. Hovnanian Forecast Acquisition, Inc. agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of any constituent corporation of the State of Delaware, as well as for enforcement of any obligation of the surviving or resulting corporation arising from the Merger, including any suit or other proceeding to enforce the right of any stockholders as determined in appraisal proceedings pursuant to Section 262 of the Delaware General Corporation Law, and irrevocably appoints the Secretary of State of the State of Delaware as its agent to accept service of process in any such suit or other proceeding. The address to which a copy of such process shall be mailed by the Secretary of State is 2495 Campus Drive, Irvine, CA 92612.
