**ASSIGNMENT OF INTELLECTUAL PROPERTY OF
6277331 CANADA INC.**

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY (the "Assignment") is entered into as of the 20th day of August, 2004 (the "Effective Date"), by and between 6277331 Canada Inc., a Canada corporation ("Canada"), and Concord Confections Ltd., a Canada corporation ("Concord Ltd").

WHEREAS, Canada desires to assign, and Concord Ltd desires to acquire, the Assigned Intellectual Property (as described herein) ("Intellectual Property");

NOW, THEREFORE, in consideration of the premises and the mutual covenants, agreements and conditions herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Canada hereby assigns to Concord Ltd all of Canada's worldwide right, title and interest in and to the Trademarks listed in the attached Schedule A, including all common law rights, together with the business and the goodwill of the business symbolized thereby.
2. Canada assigns to Concord Ltd its successors and assigns, Canada's entire right, title and interest of every kind and character throughout the world in and to all unregistered trademarks, trademark rights including at common law, trade names, trade name rights, trade dress, logos, and corporate names, together with all translations, adaptations, derivations, and combinations thereof and including all goodwill of the business associated therewith.
3. Canada assigns to Concord Ltd its successors and assigns Canada's entire right, title and interest of every kind and character throughout the world in and to all copyrightable works, copyright registrations and applications, and unregistered copyrights.
4. Canada assigns to Concord Ltd its successors and assigns, Canada's entire right, title and interest of every kind and character throughout the world in and to all software, computer programs, computer systems, modules and related data.
5. Canada assigns to Concord Ltd its successors and assigns, Canada's entire right, title and interest of every kind and character throughout the world in and to all internet domain names, including but not limited to those listed in Schedule B attached hereto, and internet websites and the content thereof.
6. Canada assigns to Concord Ltd its successors and assigns, Canada's entire right, title and interest of every kind and character throughout the world in and to all categories of confidential and proprietary information, including, without limitation, trade secrets, ideas, research and development, know-how, formulas, compositions, manufacturing and production processes and techniques, technical data, designs, drawings, specifications, customer and supplier lists and data, pricing and cost information, business and marketing plans and proposals, inventions, invention disclosures (whether or not patentable and whether or not reduced to practice),

inventor rights, reports, quality records, engineering notebooks, models, processes, procedures, drawings, designs, ingredient or component lists, plans, proposals, financial and marketing data, and all other confidential and proprietary rights information.

7. Canada hereby grants to Concord Ltd the right to sue and recover damages for past, present and future infringement of the Intellectual Property.

8. Canada further agrees to execute all documents requested in the future, and do such other acts, as may be deemed reasonably necessary to complete transfer of the Intellectual Property in accordance with the spirit of this Agreement. If permitted by law, Canada hereby grants a Power of Attorney to Concord Ltd to execute documents on its behalf to cause a transfer of recordation of the Intellectual Property.

9. The Agreement shall be binding on either party's successors, assigns, subsidiaries, and similar entities.

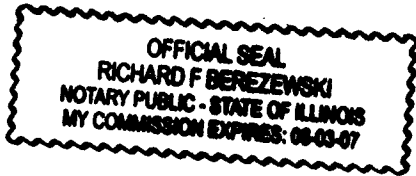
