TRADEMARK ASSIGNMENT

The Assignor authorizes and requests the Commissioner of Patents and Trademarks to record Assignee as the owner of the entire rights, title and interest in and to the Marks, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives. The Assignor warrants that is has the full right to convey the entire interest herein assigned and that it has not executed, and will not execute, any agreement in conflict herewith.
