renewals, reissues and extensions of the Trademarks or registrations of the Trademarks in the United States of America or throughout the world.

The Assignor covenants and agrees that it will, whenever so requested by the Assignee and at the Assignee's expense, execute and deliver such further instruments and take such other actions as the Assignee may reasonably require or as may be necessary or convenient for vesting in the Assignee the full benefit of all of the rights and premises hereby assigned and/or provide evidence to support any of the foregoing in the event such evidence is in the possession or under the control of the Assignor.

The Commissioner of Patents and Trademarks is hereby respectfully requested to record this Assignment in the United States Patent and Trademark Office and index same against the files of registrations herein described.

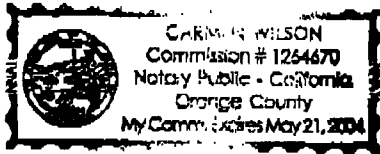
