

TERMINATION OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Doak Dermatologics, Inc., 383 Route 46 West, Fairfield, New Jersey 07004 (a New York corporation) (hereinafter the "Grantor") granted to The CIT Group / Credit Finance, Inc., 10 S. LaSalle Street, Chicago, Illinois 60603 (a Delaware corporation) (hereinafter the "CIT Group") a security interest in the following trademarks and U.S. trademark registrations: 1) "d" & Design (U.S. Reg. No. 1,087,120, registered March 7, 1978; and 2) DOAK & "d" Design (U.S. Reg. No. 1,332,773, registered April 30, 1985) (the "Trademarks"); and

WHEREAS, The CIT Group / Credit Finance, Inc. merged with The CIT Group / Business Credit, Inc. (a New York corporation) and The CIT Group / Business Credit, Inc. is the survivor of the merger; and

WHEREAS, Grantor granted CIT Group a security interest in the Trademarks to secure its obligations under a promissory note and other obligations acknowledged in an agreement between Grantor and CIT Group (hereinafter the "Note"); and

WHEREAS, in connection with the Note, Grantor executed a Security Agreement, which was recorded with the U.S. Patent and Trademark Office on September 24, 1997, at Reel 1733, Frame 0132 (the "Security Agreement"); and

WHEREAS, the secured obligations under the Note have been satisfied, and CIT Group wishes to terminate its security interest in the Trademarks.

NOW THEREFORE, CIT Group hereby terminates all of its rights, title and interest in and to the Trademarks and any corresponding U.S. and foreign trademark registrations and rights listed in the Security Agreement, together with the goodwill of the business associated therewith.
