DEED OF RELEASE

THIS DEED OF RELEASE is made September 17, 2004, on behalf of ~~by~~ Citicorp North America, Inc. DE, Corp., ("Lender"), whose principal place of business is 399 Park Avenue, New York, New York 10043, by Wire Rope Corporation of America, Inc. ("Buyer") pursuant to that certain Ancillary Order Approving Sale of Substantially all of Debtor's Assets (the "Sale Order") entered on June 24, 2003 in Case No. 02-50493 by the United States Bankruptcy Court for the Western District of Missouri (the "Court").

WHEREAS, Lender is the owner and holder of certain indebtedness secured by a security agreement (the "Security Agreement") executed on October 14, 1988, executed by Wire Rope Corporation of America, Incorporated, a Connecticut corporation ("Debtor");

WHEREAS, the Security Agreement grants Lender a continuing security interest in the Debtor's right, title and interest in and to the following trademarks and/or servicemarks (collectively the "Marks"):

including all right, title and interest in and to the Marks and any other trademarks, service marks, trademark or service mark registrations, trade names, and trademark or service mark applications of Debtor, and any other marks which have been included in any modifications to the Security Agreement after its original execution, including without limitation, common law rights and any goodwill associated with the marks.
