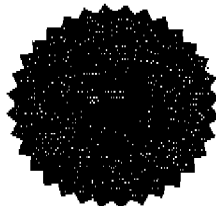

The name of the corporation is Infor Global Solutions (Rhode Island), Inc."

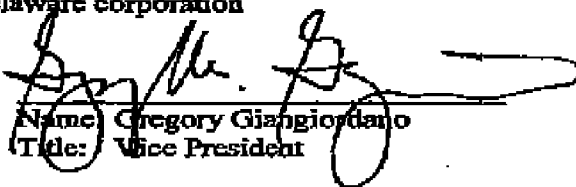
