



ASSIGNMENT
(U.S. and Foreign Trademarks)

WHEREAS, Graduate Management Admission Council, a corporation organized under and pursuant to the laws of Virginia having its principal place of business at 1600 Tysons Boulevard; Suite 1400; McLean, Virginia 22102 (hereinafter referred to as Assignor), has adopted and is using the Marks set forth in SCHEDULE A hereof which they have used in various countries throughout the world including the United States; and

WHEREAS, McGraw-Hill Higher Education, a corporation organized under and pursuant to the laws of New York having its principal place of business at The McGraw-Hill Companies; 1221 Avenue of the Americas; New York, New York 10020 (hereinafter referred to as Assignee), desires to acquire an undivided fifty percent (50%) right, title and interest in the Marks and the goodwill of the business associated with the Marks.

AND FOR THE SAME CONSIDERATION, the Assignor also hereby covenants and agrees that, at the time of execution and delivery of these presents, the Assignor is the sole and lawful owner of all right, title, and interest in and to the said registrations and applications and believes it is the sole and lawful owner of all right, title, and interest to said Marks and said goodwill associated therewith and that the same are unencumbered and that the Assignor has

good and full right and lawful authority to sell and convey the same in the manner herein set forth;

AND FOR THE SAME CONSIDERATION, the Assignor hereby covenants and agrees that the Assignor will, whenever counsel of the Assignee or the counsel of its successors, legal representatives, and assigns shall advise that it is lawful and desirable, sign all papers and documents, deliver necessary documents including original registration certificates, if available, take all lawful oaths, execute separate confirmatory assignments, and do all acts reasonably necessary or desirable to be done for the procurement, maintenance, enforcement, and defense of said Marks and registrations thereof without charge to the Assignee, its successors, legal representatives, and assigns, other than reasonable costs and expenses incurred by the Assignor or any of its employees, agents, and representatives in connection with the foregoing actions.


