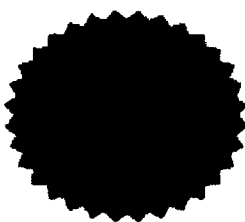

**FIRST**, that the name and jurisdiction of formation of each entity which is to merge is:
