TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made and entered into effective as of September 15, 2004 (the "Effective Date") by and among Wine Me, Dine Me, Inc. d/b/a Oceans Grill, a California corporation with an address at P.O. Box 1339, Pismo Beach, CA 93448 ("Assignor"), on the one hand; and B.R. Guest Trademark Company, Inc., a New York corporation with an address at 206 Spring Street, 5th Floor, New York, NY 10012 ("BRG"), on the other hand.

WHEREAS, Assignor is the owner of all right, title and interest to the trademark, service mark, and trade name, OCEANS (the "Mark"), the goodwill associated therewith, and U.S. Trademark Registration No. 1,351,107 for the Mark (the "Registration"); and

WHEREAS, BRG is desirous of acquiring the Mark, the goodwill associated therewith, and the Registration.

NOW THEREFORE, for good and valuable consideration, including but not limited to payment of \$1,500, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- (1) Assignor warrants and represents that it is the owner of all right, title, and interest in and to the Mark, the goodwill of the Mark, and the goodwill of the business appertaining thereto and/or symbolized thereby, and the Registration, free and clear of all liens and encumbrances.

- (2) Assignor hereby sells, assigns and transfers forever, free and clear of all liens and encumbrances, to BRG and its successors and assigns, all right, title, and interest in and to the Mark, together with the goodwill of the Mark and the goodwill of the business appertaining thereto and/or symbolized thereby, and the Registration, and all income, royalties, damages and payments now or hereafter due or payable in respect to the same, and all causes of action (either in law or in equity) and the right to sue, counterclaim and recover for past, present and future infringement and/or dilution of the same.
- (3) Assignor agrees to execute any additional instruments reasonably requested by BRG to effect the substance of this Assignment.
- (4) Assignor agrees to provide BRG with documents reasonably sufficient to prove continuous use of the Mark from at least as early as December 17, 1984 through the present.
- (5) Assignor shall begin phasing out use of the Mark beginning on the Effective Date, and shall cease all use of the Mark on or before the first anniversary of the Effective Date.




