TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made effective this 5th day of January, 2004, by and among Paoli, Inc., an Indiana corporation ("Paoli"), Orleans Corporate Services, Inc., a Delaware corporation ("Orleans" and together with Paoli, the "Assignors"), and HON Technology Inc., an Iowa corporation ("Assignee"). Capitalized terms used herein and not defined shall have the meaning assigned to them in the Asset Purchase Agreement (as defined below).

WHEREAS, Assignors, Assignee, Klaussner Furniture Industries, Inc., a North Carolina corporation, PIA Inc., an Iowa corporation, and HON INDUSTRIES Inc., an Iowa corporation, have entered into an Asset Purchase Agreement, dated as of December 16, 2003, as amended through the date hereof (the "Asset Purchase Agreement"), pursuant to which Assignors have sold substantially all of their assets and assigned certain of their liabilities related to the Business (as defined in the Asset Purchase Agreement), which includes the trademarks and trade names listed on Schedule A attached hereto (collectively, the "Marks"), to Assignee;

WHEREAS, Assignors have adopted, used and are currently using the Marks in connection with the Products, and have agreed to assign to Assignee all of Assignors' right, title and interest in and to the Marks and the goodwill associated with the use of the Marks in connection with the Products.

NOW, THEREFORE, in consideration of the premises set forth above and in the Asset Purchase Agreement and for other good and valuable consideration, the receipt of which is hereby acknowledged:

Assignors hereby sell, assign, transfer, set over and deliver to Assignee, Assignors' entire right, title and interest in and to the Marks (including any common law rights that may exist and are associated therewith), together with the goodwill of the business symbolized by them, the same to be held and enjoyed by said Assignee, its successors, permitted assigns or legal representatives, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the Marks, along with the right to sue for past infringements and collect same for Assignee's sole use and enjoyment.


